Our Transparency Policy reflects our commitment to operating with integrity, even when difficult choices arise. The policy presents the position taken by Gaudin L. Charles Ministries regarding transparency and accountability, as well as associated arrangements, including in respect of international agreements and arrangements. Gaudin L. Charles Ministries is committed to ensure that any international activities in conducts are undertaken by Gaudin L. Charles Ministries and any of its affiliates, partners, donors, colleagues, and each of their respective officers, employees, agents, contractors, and consultants, having regard to principles of transparency and accountability.

The purpose of this policy is to establish processes, procedures, and controls to ensure that Gaudin L. Charles Ministries and each of the bodies corporate, entities, and persons set out in the preceding paragraph conduct themselves in a manner consistent with overall transparency and accountability. We seek to improve trust and openness in the functioning of our organization, and we aim to show our congregation members that their contributions are going to our vital missions. In addition, we strive to operate according to the laws of the host nation and that we are operating in a spirit of good will and integrity.

A transparency policy is a crucial part of any religious organization, referring to the openness and accessibility of financial information, practices, and processes of the organization. By providing clarity and visibility into their financial affairs, religious organizations such as Gaudin L. Charles Ministries ensure that trust, accountability, and support from congregation members is built and

maintained. In addition, transparency is vital to maintain the integrity of the organization, uphold ethical standards, and foster the confidence of the congregation. Thus, Gaudin L. Charles Ministries will adhere to laws, regulations, denominational guidelines, and established internal policies and procedures, and will implement practices such as regular financial accounting, independent audits, and clear communication.

Charles Ministries strives to embody Gaudin Charles' focus on integrity by promoting the values of honesty, respect, and love. We strongly believe in standing up for what is right and living a life of Godliness. To that effect, we refuse to compromise our integrity or the Words of God.

Who We Are

Gaudin L. Charles Ministries endeavors to transform lives and inspire positive change. We hope to serve as a beacon of light in an incredibly dark world by inspiring faith, empowering personal transformation through the love of God, and perform compassionate outreach to the community. Our goal is a brighter and more hopeful future through our outreach and Ministries. In addition,

Our overall mission is to build a vibrant community of love through charitable works, outreach to the marginalized, and championing social justice. We strive to guide hearts toward God by offering hope and support to those afflicted by misfortune or injustice. We seek to offer solace and meaning and inspire a transformation that echoes throughout the rest of time.

The overarching vision of Gaudin L. Charles Ministries is to spread the transformative message of the Gospel of Jesus Christ worldwide. We hope not only to spread the word of God and the teachings of Jesus, but to inspire the souls of individuals to dedicate their lives to a relationship with God. Our vision is one of salvation and redemption through Christ's sacrifice and an enduring and permanent relationship with God.

At Gaudin L. Charles Ministries, we believe that honesty and openness are sacred virtues. We are dedicated to furthering the following values:

- Respect We spread the Gospel of Jesus Christ through respect to our community, and we strive to spread the love of God throughout the world.
- Trust We value trust between our leadership and our members, as well as trust between our organization and the greater community.
- Fairness We value fairness and justice in all that we do and stand for.
- Honesty We believe in the value of honesty in all that we do.
- Integrity We value integrity in our organization so that a sense of trust and confidence in our organization can be encouraged.

- Purpose We strive to serve our community and are committed to carrying out this sense of purpose to the best of our ability.
- Accountability We value accountability so that our resources are used for their intended purpose and so that fraud, waste, or unethical practices are prevented.
- Teamwork We work as a team to spread the word of God and to uplift the lives of those in our community,

Operations

Our Ministries has a profound commitment to empowering the lives of those in our community and achieving a permanent and positive transformation. Our ultimate aim is to have a lasting positive impact on the lives of all that we serve. To that end, we offer spiritual guidance to those in need of it, and work with leaders in our community to address social injustices as well as operate educational programs for people to improve their lives.

We operate as a religious organization, and thus, there is a greater expectation from each person, especially from leaders, to demonstrate exemplary stewardship in financial matters by ensuring that they conform to biblical principles, professional standards, the relevant laws and/or regulations, and denominational policies, if any. To that end, we have implemented regular financial reporting, independent audits, and have policies of clear communication regarding financial matters, so that trust, credibility, and openness are fostered in our operations. We seek to ensure that the donations of our congregation are used where they can do the most good and seek to prevent fraud and other unethical behavior by our leaders, so that our standing in the eyes of the community does not falter and thus harm our mission.

We are committed to conducting our Ministries' operations in a way that is above reproach. Being transparent about how we do business and utilize donations is of the utmost importance, as it builds trust with our supporters and minimizes risks. We have reporting procedures in place for all finances donated to our organization from our congregation or from outside sources. We also protect against embezzlement, theft, and fraud by promoting transparency in our financial affairs. In addition, we have a system of verification of checks, invoices, and payables to help stop fraud and embezzlement, and we do thorough background checks on all personnel that we hire. In taking these steps, we endeavor to help mitigate the risks of unethical behavior on the part of our organization and thus protect our credibility and the integrity of our mission and our organization.

We foster leadership in our organization so that our message and our mission survive to the next generation. We provide educational opportunities for the young so that they can develop their life skills and also to provide an example of Christian love, charity, and integrity. In addition, we foster leadership through subsidiaries, who promote programs of ours such as outreach programs and international preaching tours. We train new leaders to continue our mission and to safeguard the values that we stand for through changing times. We foster leadership through the process of training ministers and other workers to carry out our mission. We strive to build a leadership pipeline of future ministers, and to that effect, offer training in ministries and church leadership, so that the mission of Gaudin L. Charles Ministries survives into the next generation. Our ministers offer mentoring, discipleship, and apprenticeship for aspiring ministers, and lead through example by performing charitable deeds and uplifting the lives of our congregations and the wider

Our goal is to ensure that our members feel confident that their donations are going towards the work that we do, rather than into the pockets of our leaders. For that reason and with a written request, we will allow anyone the ability to look into our finance themselves. This allows our donors and partners to see precisely how their contributions further our mission. and to see where the donations are going. We operate according to a strict policy of financial transparency, and this helps us to continue spreading the word of God. While remaining prudent, we strive for full transparency, believing that integrity and openness reflect our devotion to moral stewardship. We take our duty as servants seriously, managing resources wisely and being fully transparent.

Responsibility

Gaudin L. Charles Ministries have an obligation to uphold the highest standards of ethical conduct and transparency in all of our dealings. We have a unique responsibility, one which we dare not abdicate. For that reason, we offer transparency and accountability in all that we do, and we take our responsibilities to ourselves and to our communities very seriously. We have a responsibility to live up to our ideals to the best of our ability, and we need to uphold our values in our daily conduct as well as our dealings with others. To that extent, we hold ourselves to strict standards of integrity and accountability. In addition, we have a responsibility to ensure that the services and support that we provide continues, and so we make every effort to train our future leaders and workers in making decisions according to God's teachings and to strive to help community members in need. We strive to provide outreach and services to our community and to all in need of care. This is a responsibility that we do not take lightly.

We have a responsibility to ourselves as well. We have a responsibility to uphold the ideals of honesty, integrity, and accountability in our private and public lives. We intend to do this by ensuring absolute transparency in all that we do. Gaudin L. Charles, personalized honesty and integrity in his work, and we must strive to be worthy of his name. Financials

In managing our finances, we openly and clearly disclose the financial information and transactions to our members and the wider community. We strive to ensure that our funds are used appropriately and in line with the values of Gaudin L. Charles Ministries. We also aim to improve the decision making within our Ministries through openness and honesty, so that better decisions about budgeting, fundraising, and the allocation of resources is made.

We create a financial statement laying out all of our transactions, expenditures, and donations received on a monthly basis. We prepare this statement for the purposes of financial reporting, budgeting, record keeping, and internal controls, and to present an accurate picture of our financial status to our congregation. All of our financial statements are written in plain English so that our congregation can easily understand them. Our financial statements are done according to the relevant denominational guidelines, which provide clear directives on financial practices and help to reduce the risk of mismanagement or theft. We disclose these openly to build trust and demonstrate our value of accountability. These statements include an income statement, a balance sheet, and a cash flow statement, which provide a complete view of our finances and activities.

We aim to be good stewards of donations, and thus we list off all expenditures and income in our statements and make them available to our congregation and the general public. We clearly disclose all sources of revenue, including donations, tithes, and offerings, as well as expenses such as salaries, utilities, and programs. We aim to give our congregation a clear picture of how their contributions are being utilized. Accountability

We encourage anyone who witnesses misconduct at our Ministries to speak up and inform the church leadership about the issue. If the behavior does not stop or violates the law, then we encourage them to report the behavior to the authorities. Our leaders answer to the law and to God.

To enforce our vision of accountability, we comply with all relevant state, local, and federal laws, and enforce strict financial regulations against potential misconduct. We have procedures for reporting embezzlement, fraud, etc. to the authorities, and we take our obligation to do so extremely seriously. In addition, we have independent audits conducted on a regular basis, providing an unbiased assessment of our financial records and practices, as well as ensuring compliance with regulations and providing the necessary financial transparency. We enforce our policies by punishing any leaders who violate our policies or the law to the greatest extent possible and turn anyone engaged in illegal activities over to law enforcement for prosecution.

Compliance with the Laws

Gaudin L. Charles Ministries know that trust between our You and Us is vital to our community. That's why we are committed to following all laws regarding transparency and openness without compromising our (core) values and most importantly though, without compromising the Words of God. In all of our activities where we will operate inside of them. Illegal activities such as fraud, embezzlement, etc. are not only an abuse of our spiritual authority but are prohibited by the law as well. We as a Ministries are cognizant of the need to operate under the law, and pledge ourselves to comply with the laws of all nations that we operate our Ministries in.

Relationships with the greater community are vital to our work, so we will do our utmost to follow the laws of the Host State that we are conducting our Ministries in. We are guests of the community, and as such, we have an obligation to obey the law in conducting our Ministries. We hold ourselves to standards of accountability and integrity, and so we want any behavior that falls short to be held accountable. Cooperation with the host state is essential to completing our mission, and thus transparency and accountability are necessary.

We will comply with all federal laws related to taxes and church finances. We pledge to align our policies with all applicable laws and regulations to increase financial transparency. We will obey all tax laws, reporting requirements, and any other legal obligations imposed by the federal government. In conducting our Ministries, we strive to uphold the values of integrity and accountability in all things, and to do so we will cooperate with the federal authorities. In addition, we will report any violations of federal law to the authorities. We strive to spread the word of God and uplift the lives of the greater community, and financial misconduct and law-breaking hurts our credibility with the community and thus our ability to achieve what we strive for. We want to establish trust and credibility, and to do that we make a consistent effort to comply with federal tax and financial laws and strive to hold accountable those who fail to do so.

We will seek to conduct ourselves as good guests and good international travelers and will conduct our outreach in an open and transparent manner so that there are no international incidents or scandals that would affect our ability to go out and spread the word of God and aid those in need.

We will obey all the laws of the host nation as well. When outside of the United States, we will make an effort to research the laws of the nation we are operating in and conduct our organization in accordance with those laws. We understand that many nations have a different legal and/or political system than the United States, and thus we will endeavor to be honest and accountable in operating our Ministries throughout the world. In all nations that host us, we will strive not only to obey the law, but also to live up to our standards as well. We will obey all relevant laws related to religious organizations and to taxes and financial operations as well. We seek to have a positive relationship with all communities that we operate in both in the United States and abroad, and to do so, we comply with all applicable laws.
